additional fees levied by airlines, cruise companies (see terms of Celebrity Cruises at www.celebritycruises.com), and tour operators (including A.C.T.) in accordance with their regulations, penalties, and out of pocket expenses (telephone calls, cables, etc.). Cancellations made 60 days or less before departure: No refund (100% penalty).

These special coach class group tickets are totally NONREFUNDABLE once issued.
